Mobile Logistic Company Limited both have the same major shareholders, namely Saha Pathana inter - holding Public Company Limited with 24.98% in Saha Pathanapibul Public Company Limited and 9.00% in Mobile Logistic Company

Limited.

4. General characteristics of the transaction:

- Transection class : To provide the financial support in proportion to shareholding

in the Joint Venture Company which to a related party.

- Transection value : Loan amount Bath of 3,550,000.-. This transaction is

considered to be a related transaction of listed company. which is within the guidelines of a connected transaction in relation to provision of financial assistance in the form of joint guarantee based on the proportion of investment as prescribed in the announcement of the Capital Supervisory Board on Rules of Connected Transactions, the value of which is less than 100 million Baht or less than 3% of NTA, whichever is less. It is noted that 3% of NTA as in March 31, 2022 was approximately THB 717.12 million. Accordingly, such transaction requires approval from the Board of Directors and disclosure of the information to the Stock Exchange of Thailand, but no shareowners' approval is required.
