5. <u>Total Remuneration Value</u>:

From the Property Appraisal Report as of December 29, 2021 by AGENCY FOR REAL ESTATE AFFAIRS CO., LTD., a professional for Property Appraiser which obtaining approval from the SEC, a total appraised market value 115,430,000.00 baht (one hundred fifteen million four hundred and thirty thousand baht), therefore, the value of the purchase price of this transaction is lower than the market price.

6. Source of Fund:

Working capital from BANGKOK TOWER (1999) CO., LTD.

7. Objectives of Transaction:

Property investment and Future business expansion.

8. Size of transaction:

This size of transaction is considered to be a transaction of listed company prescribed in the notification of the board of Governors of the Stock Exchange of Thailand in category of connected transactions as the category of assets or services, transaction size more than 1 million baht but less than 20 million baht, or more than 0.03% but less than 3% of NTA, whichever is higher. In this regard, the Disposal of Assets Transaction is not regarded as the disposal of assets pursuant the Notification of the Capital Market Supervisory Board No. TorJor.20/2551 Re: Rules on Entering into Material Transactions Deemed as Acquisition or Disposal of Assets (as amended) and the Notification of the Board of Governors of the Stock Exchange of Thailand Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition and Disposition of Assets B.E. 2547 (2004) (as amended), this transaction size based on the total value of consideration criteria, is 0.29% of the total assets of the Company. (Calculated from the consolidated financial statements of the 3rd quarter as of September 30, 2021), which when combined with the transaction size in the past 6 months with a total value of 1.81, with a transaction size of less than 15%, this transaction has the small size, therefore, the Company is not required to disclose an information memorandum of such transaction to the Stock Exchange of Thailand.
